APPLICANT INFORMATION (please print)

APPLICATION PROCESS

Membership in the Club is a privilege obtained through the successful completion of the application process and of admission approved by the Membership Committee, which process includes, without limitation, the following steps:

1. Submission of this Application must be accompanied by an Application Fee in the amount of \$500. The Application Fee shall not accrue interest. Neither the acceptance of the Application nor depositing of the check for the Application Fee by the Club shall create or imply any obligation to admit the Applicant to membership.
2. Evaluation by the Membership Committee of the Applicant or individual(s) sponsored by the Corporate Applicant; in the conduct of such evaluation, the Membership Committee, among other things, may consider many and varied factors about the Applicant, such as education; standing and reputation in the community; credit worthiness and financial ability; social compatibility with other Club members; and legal history (e.g., civil and criminal proceedings in the last three years); and may require a personal interview of the Applicant with member(s) of the Membership Committee; the Applicant will be notified by mail of the admission decision.
3. If the Applicant is admitted to immediate membership to the Club, the Application Fee will be credited against the applicable Dues and shall be due within thirty (30) days after the date of such admission notice; however, the

Applicant may not enjoy or exercise member privileges until the dues have been paid in full.

4. If the Applicant is approved but not for immediate admission to membership, then at the discretion of the Membership Committee the Applicant may be put into the Applicant Waiting Pool for up to two years, and the Application Fee shall be retained by the Club pending a later decision on the immediate admission to membership.
5. If the Applicant is not admitted to membership, the Club will refund the Application Fee and such individual may reapply later.

APPLICANT WAITING POOL

If the number of Applicants approved by the Membership Committee exceeds the number that can be admitted to membership, then the approved Applicants not so admitted may be put into the Waiting Pool for a period of up to two years. When vacancies occur in the membership ranks the Membership Committee may select Applicants from the Waiting Pool for admission to membership. If a Applicant has been in the Waiting Pool for a two-year period, then at the end of such period the Club will notify the Applicant by mail (accompanied by a return of the Application Fee) that the Applicant has not been admitted to membership and may or may not reapply for membership.
